- 一． 同學必須通知家長留校時間。

Appendix 1: Regulations for the use of study rooms

Opening date : School days from 21 September 2015 to 17 December 2015
Opening hours : 5:00 p.m. — 7:30 p.m. (Summer time: 4:30 p.m. — 7:30 p.m.)
Venue : Rooms 105 & 106

1. Students must inform parents of their duration of stay after school.
2. Study rooms are opened for studying. Students should use all study room facilities with care. Moving or damaging of any facilities is not allowed.
3. Before entering the study rooms, students must sign in and clearly write their names, classes and time of entry on the designated register.
4. Students should sign out of the study rooms after use.
5. Students who use the study rooms should stay in the designated classrooms. Loitering in other areas is not allowed.
6. Students should be considerate and keep quiet in the study rooms. Compliance with classroom rules is required.
7. Students should not occupy seats in the study rooms when they are not using the seats.
8. All non-study activities are strictly forbidden in the study rooms.
9. Students should keep their personal belongings safe. They will be responsible for any loss of their personal belongings.
10. Students must follow the instructions given by teachers, teaching assistants or janitors. They should inform the teacher or the teaching assistant on duty immediately in case of sickness or accidents.

Students who violate the above rules will be forbidden from using the study rooms. In those cases, the school has the authority to revoke a student's right of using the study rooms and to impose relevant punishments based on the circumstances.
